NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL THAT:


The abstract of votes cast is hereby accepted for the November 5, 2013 Municipal Special Election as to the official results reported election night, and the following are elected:

ACTION REQUESTED:

The City Council is being asked to adopt Resolution 2013-129 approving the canvass of votes cast at the November 5, 2013 Special Election for Ward 4.

SUMMARY:

The Special Election was held on Tuesday, November 5, 2013. Overall voter turnout was approximately 17 % (Ward 4, Precinct 1 – 27%; Ward 4, Precinct 2 – 8%). The official abstract with all statistics is attached. The election results for Ward 4 are noted below:
